ORDER

Whereas, the Sah-Vikas Cooperative Group Housing Society Ltd., 7th Avenue, Plot No.68, I.P.Extension, Patparganj, Delhi-110092, is registered with this Department vide Regn. No.428/GH.

And whereas, a representation has been received from the Secretary of the society, wherein, it has been requested to appoint a Returning officer to conduct the elections in the society.

And whereas, the last election of the society was conducted on 28.02.2021. However, Secretary of the society has informed that the present office bearers do not wish to continue, hence it was decided in the GBM of society to request RCS office for appointment of Returning Officer to conduct fresh election in the society.

And whereas, in view of the above circumstances, the Competent Authority has appointed Sh. I S Gulati, Retd. ITO, as Returning Officer in the aforesaid society u/s 35(1) of DCS Act, 2003 to conduct election in the Society.

Now, therefore, I, Sandeep Yadav, Asstt. Registrar (Section-VII), O/o RCS hereby convey the approval of the Competent Authority to appoint Sh. I S Gulati, Retd. ITO, Returning Officer in the aforesaid society u/s 35(1) of DCS Act, 2003 to conduct election in the Society within a period of sixty days from the date of his appointment. He is entitled to receive consolidated amount of Rs.6,000/- (Rs. six thousands only) as honorarium out of the society funds.

The other expenses of the election will be met out from the funds of the society. The election of the Managing Committee of the aforesaid society shall be conducted as per the guidelines for the elections available in Rule 53 and of Schedule-II of DCS Rules, 2007.

Further, the President/Secretary & MC member of the society is hereby directed to cooperate and provide all requisite documents/information to the Returning Officer within 07 days from the date of receipt of this order.
