ORDER

Whereas, the Sawan Cooperative Group Housing Society Ltd., Plot No.01, Sector-03, Dwarka, Delhi-110078, is registered with this Department vide Regn. No.1368/GH.

And whereas, a representation has been received from the Secretary of the society, wherein, it has been requested to appoint a Returning officer to conduct the elections in the society.

And whereas, in view of the above circumstances, the Registrar Co-operative Societies has appointed Sh. Pritam Singh, Retd. DANICS, Administrator-cum-Returning Officer in the aforesaid society u/s 35(5) of DCS Act, 2003 to conduct election in the Society.

And whereas, a representation was received from Sh. Pritam Singh, Administrator-cum-RO of the Society stating that the election could not be conducted due to the third wave of COVID-19/ Omicron Variant.

Now, the Registrar of Cooperative Societies, GNCT of Delhi in exercise of powers vested under DCS Act & Rules, hereby regularize the previous period w.e.f. 04.01.2022 till date of Sh. Pritam Singh, DANICS (Retd.) as Administrator-cum-RO and further appoints him de-novo as Administrator-cum-RO in the aforesaid Society u/s 35(5) of DCS Act, 2003 read with Rule 53 and Schedule II of DCS Rules, 2007 for a period of 90 days alongwith permission to initiate the process of election under the provisions of Schedule II of DCS Rules, 2007. He is entitled to receive Rs.10,000/- (Rs. Ten Thousands only) per month as honorarium and conveyance charges, out of the society funds.

The other expenses of the election will be met out from the funds of the society. The election of the Managing Committee of the aforesaid society shall be conducted as per the guidelines for the elections available in Rule 53 and Schedule-II of DCS Rules, 2007.
