ORDER U/S 35 (5) OF DCS ACT, 2003

Whereas, Dera Ismail Khan Co-operative House Building Society Ltd. is registered vide registration No.160NW-HB with this department under the provisions of DCS Act & Rules and Bye-Laws of the Society;

Whereas, Mr. Rajeev Ranjan, SDM (Civil Lines), who was appointed as Administrator-cum-Returning Officer vide this office order dated 29.11.2021 in place of Sh. R.P. Aggarwal, ADM (North-East), has resigned from the post of Administrator-cum-Returning Officer on personal reasons.

And whereas, the Registrar Co-operative Societies has approved for the appointment of Sh. 
