ORDER

Whereas Galaxy Coop GHS is registered vide Registration No.279-GH with this department under the provisions of Delhi Co-operative Societies Act/Rules & registered Bye-Laws of the society.

And whereas, the existing Management Committee has been dissolved vide its Executive Committee meeting held on 01/06/2020 to conduct the election of new Management Committee.

And whereas, in exercise of the powers vested under Section 35(5) of DCS Act, 2003, the Competent Authority has approved that the affairs of the society shall be managed by an Administrator-cum-Returning Officer.

And whereas, this office had appointed Sh. R.K. Bhalla Accounts Officer, Education Department, as Administrator-Cum-Returning Officer in Galaxy Coop GHS (Regn. No.279-GH) under section 35 (5) of DCS Act, 2003 to look after the day-to-day affairs of the society and to conduct the election of the M.C. within 90 days from the date of appointment as Administrator vide this office order dated 03.03.2021 and tenure extended vide this office letter dated 07.10.2021 with the direction to complete the election of the society within 90 days under Rule 1 (iv) of Schedule II of DCS Rule, 2007 without conducting Audit of the Society (Rule 53) and to look after the day to day affairs of the society.

And whereas, Sh. R.K. Bhalla, Administrator-Cum-Returning Officer shown his inability to continue as Administrator – cum – Returning Officer, therefore, his resignation has been accepted by this office. The past period w.e.f. 06.01.2022 to till date in r/o Sh. R.K. Bhalla is being regularized.

Now, therefore, I, Satish Kumar Gupta, Assistant Registrar (GH/Sec-III) hereby convey the approval of the Competent Authority to appoint Sh. Gurkirpal Singh, (Retd.), VATO, GNCTD as Administrator in place of Sh. R.K. Bhalla in Galaxy Coop GHS (Regn. No.279-GH) under section 35 (5) of DCS Act, 2003 to look after the day-to-day affairs of the society and to conduct the election of the Managing Committee of the society within 90 days under Rule 1 (iv) of Schedule II of DCS Rule, 2007 without conducting Audit of the Society (Rule 53)

He will be paid Rs.10,000/- (Rupees Ten Thousand Only) per month as remuneration from the Society's fund for this purpose.
