






Agenda for clearance of six membership of Shabad CGHS Ltd. was placed before the Rule 90 committee. Registrar apprised the Hon'ble Chairperson and other members of the committee about the facts of the case.

Matter was discussed at length in the meeting. The Rule 90 Committee decided to accords its approval for forwarding the name of Mrs. Jaya Asrani (M.S No. 406), Sh. Mahesh Kumar Jethani ( M S NO. 431 ) and Sh. Ashwani Sharma (M S No. 434) to DDA for draw of lots, subject to the conditions that if these three are the original members of the society, the society shall submit proof of said three members being


original members. Alternately, if these three members are enrolled against vacancies, the society shall submit the proof of having followed the due procedure and submit the proof of advertisements for filling the vacancies.

In respect of the membership of Dheeraj Chhabra (M.S. No. 413), the case was discussed at length. It has been apprised to the committee that certified copies of Resignation of Sh. Dheeraj Chhabra from the membership of the Society was available in the records received from the CBI. Further, it has also been observed from the records that Managing Committee resolution dated 31.03.2004 which is provided by the CBI that name at serial No. 18 for membership no. 413 is Dahiya in place of Dheeraj Chhabra. The copy of Membership Application of Sh. Dheeraj Chhabra submitted by the Society is different from the certified copy of membership application provide by the CBI for the said member. Therefore, the Rule 90 committee rejected the case of Sh. Dheeraj Chhabra.

In respect of the membership of Shri Deepesh Satija & Ashok Satija (M S No. 448) and Shri Varun Aggarwal (M S No. 449), Rule 90 committee discussed at length and decided to accord approval for forwarding names of above 02 members to DDA for draw of lots subject to the condition that the society must submit the proof of having conducted the draw in the presence of representative of RCS office.
