Whereas, the Silver Oak Cooperative Group Housing Society Ltd., Plot No.109, I.P.Extension, Delhi-110092, is registered with this Department vide Regn.No.406/GH.

And whereas, Sh. Bipan Kumar, DANICS (Retd.) was appointed as Administrator-cum-RO vide this office order dated 14.07.2021 but he has resigned from the post of Administrator-cum-RO vide his e-mail dated 16.12.2021.

And whereas, in view of the above circumstances, the Registrar Co-operative Societies has accepted the resignation of Sh. Bipan Kumar.

Now, therefore, I, Sanjay Jha, Asstt. Registrar (Section-VII)/Link Officer, O/o RCS hereby convey the approval of the Registrar Co-operative Societies to appoint Sh. Devesh Kumar Garg, Asstt. Director, DSSSB, GNCT of Delhi as Administrator-cum-Returning Officer in the aforesaid society u/s 35(5) of DCS Act, 2003 to manage the day-to-day affairs of the society and also to conduct election in the Society within a period of ninety days from the date of his appointment. He is entitled to receive Rs.10,000/- (Rs. Ten Thousands only) per month as honorarium and conveyance charges, out of the society funds.

The other expenses of the election will be met out of the Society funds. The election of the Managing Committee of the aforesaid society shall be conducted as per the guidelines for the elections available in Rule 53 and of Schedule-II of DCS Rules, 2007.

Further, the Ex-President/Ex-Secretary, MC members of the society are hereby directed to handover all the records/documents of the society to the Administrator-cum-Returning Officer within 07 days from the date of receipt of this order.
