By this order, I shall dispose of the appeal of Appellant(s) under section 91 of DCS Act 2003 against the Respondent Society for not transferring membership in favour of Appellant(s) as per their respective applications.

The Appellant(s) stated in the appeal that the appellants jointly purch sed a flat on 04.06.2002 in Ghalib Apartment, Parwana Road, Pitam Pura, Delhi-34 from Sh.
