In view of above, the Competent Authority in exercise of the powers vested with him under DCS Act & Rules, is pleased to appoint **Sh. J.B. Kapil, Administrative Officer, DFS, Moti Nagar, New Delhi-110015** in place of Sh. Ajay Rawal, Secretary to Hon'ble Speaker, Vidhan Sabha **as Inspecting Officer u/s 61(1) of DCS Act. 2003** to conduct an inspection in Narwana CGHS Ltd., Narwana Apartments, 89, I.P. Extn., Patparganj, New Delhi-110092 on the complaint of 60 signatories of the said society.
