ORDER

Whereas, The Jyoti Raw Phooley Co-operative Thrift & Credit Society Ltd. F-144, Gali No.-2, Ganga Vihar, Delhi – 110 094 is registered with this department at Regn. No. 04TC/NE under the provisions of DCS Act and Rules.

And whereas, an order under section 61 of DCS Act,2003 was issued vide order No.F.47/TC/RCS/Sec-3/2019/459 dated 31/10/19 appointing Sh. Anil Kumar, Administrative Officer LNJP as Inspection Officer u/s 61 of DCS Act 2003 in The Jyoti Raw Phooley Co-op T/C Society Ltd. to conduct inspection into the complaints received in this office.

And whereas, Inspection under section 61 of DCS Act, 2003 had been completed and Sh. Anil Kumar, Inspecting Officer had submitted the Inspection Report dated 25/06/2021. Further, vide this office order no. 248-250 dated 14/09/21 Sh. K.K.Satija, Dy. Director(Plg) was appointed as inquiry officer u/s 62 of DCS Act 2003 in The Jyoti Raw Phooley Co-op T/C Society Ltd. However, an information was received from him vide his communication dated 14.01.2022 that due to some health issues(suffering from COVID 19) and closure of offices in November due to environmental pollution and closing of offices due to COVID pandemic he was unable to conduct the inquiry of The Jyoti Raw Phooley Co-op Society Ltd. and requested to cancel his appointment as inquiry officer.

Now, therefore, the Registrar Co-operative Societies, GNCT of Delhi in exercise of the powers vested under DCS Act & Rules, is pleased to appoint Dr. Surender Kumar Bhandoriya, Addl. Director, Dte. Of Education as Inquiry Officer under Section 62 of DCS Act, 2003 in place of Sh. K.K.Satija, Dy. Director(Plg). He shall fix the responsibility of person(s)/officer bearer(s) of the society on the basis of findings given in the Inspection report dated 25/06/2021 of Sh. Anil Kumar. The society shall pay Rs.15000/-(Rupees Fifteen Thousand only) as remuneration to Sh. Surender Kumar Bhandoriya from the funds of the society for conducting the inquiry. The inquiry shall be completed within a period of 60 days of receipt of this order.
