ORDER U/S 35 (5) OF DCS ACT, 2003

Whereas the Cabinet Secretariat Co-operative Group Housing Society Ltd. is registered vide registration No.35-GH with this department under the provisions of Delhi Cooperative Societies Act, Rules and bye-laws of the Society;
