ORDER U/S 35 (1) OF DCS ACT, 2003

Whereas, Chanakya Co-operative Group Housing Society Ltd. Plot No. 23, Sector-4, Dwarka-Phase-I, New Delhi-110078 (hereinafter termed as Society) is registered vide registration No.747-GH with this department under the provisions of DCS Act & Rules and Bye-laws of the Society;

And whereas, the Special General Body Meeting of the Society which was held on 08.05.2022, wherein majority of the members decided to dissolve Management Committee and requested this department for the appointment for Returning Officer to hold fresh election to constitute new Management Committee.

Section 35(1) of DCS Act, 2003 reads as under:-

"35. Election and nomination of members of committee.

(1) The superintendence, direction and control of the preparation of the electoral rolls for, and the conduct of elections of the members of the committee of, a co-operative society shall be vested in the committee which shall appoint returning officer who shall not be a member or an employee of the society:

Provided that on the request of the committee or one-sixth members of the society, and in case of dispute in a society, the Registrar may appoint the returning officer to conduct the election of a society."

And whereas, the Registrar Co-operative Societies has approved the appointment of **Mr. Naresh Kumar, AAO (W&M)** as Returning Officer under Section 35 (1) of DCS Act, 2003 for holding the election of the Managing Committee of the Society read with Rule 53 and Clause 1 of Schedule-II appended to DCS Rules, 2007 and also as per the bye-laws/Model bye laws of the Society within 90 days from the issue of this order. The expenses incurred on the conduct of the election will be met out from the funds of the Society.

The Society is further directed to furnish the relevant documents/papers to the Returning Officer within 07 days from the issue of this order. **Mr. Naresh Kumar, AAO (W&M)** will be paid Rs.6,000/- (Rupees Six Thousands Only) as remuneration for conducting election from the fund of the Society.
