ORDER U/S 35 (5) OF DCS ACT, 2003

Whereas, Doctors and Administrators of AIIMS Co-operative Group Housing Society Ltd. (Regn. No.95/GH) is registered with this department under the provisions of DCS Act, Rules & Bye-laws framed thereunder;

And whereas, Sh. Vikram Raj, Member of Society Ltd. has resigned as Secretary and Member of the Management Committee which was recorded in the minutes of the Management Committee on 29th August, 2021. Where he has stated that "As per the rules governing the society, vide clause 44(1) and (2) b the society have failed to appoint a successor because of which I have not been able to hand over charge till date. As much time has passed and my repeated requests for the same have not been responded in a positive manner, I take this opportunity to inform you that I shall not be responsible for any action taken by the Management Committee post my resignation nor will I be responsible for any documentary lapses post my resignation."

And whereas, the Registrar Co-operative Societies has approved the name of Mr. Bajrang Lal, Retd. DANICS for the appointment of Administrator-Cum-Returning Officer under Section 35 (5) of DCS Act, 2003 in Doctors and Administrators of AIIMS Co-operative Group Housing Society Ltd. (Regn. No.95/GH) with immediate effect. A remuneration of ₹.10,000/- (Rupees Ten Thousand Only) per month and Traveling Allowance applicable as per circular dated 29.09.2016 (copy enclosed) shall be paid from the fund of the Society and to hold the election of the Managing Committee of the Society within stipulated period of 90 days from the date of appointment as Administrator-Cum-Returning Officer.

The Ex-Managing Committee of Doctors and Administrators of AIIMS Co-operative Group Housing Society Ltd. (Regn. No.95/GH). is hereby directed to handover the charge of the record of the Society/ relevant documents to the Administrator-Cum-Returning Officer immediately under intimation to this office within 07 days from the issue of this order.
