ORDER U/S 35 (5) OF DCS ACT, 2003


Whereas, Dera Ismail Khan Co-operative House Building Society Ltd. The Mall, Derawal Nagar, Delhi-110009 (hereinafter termed as Society) is registered vide registration No.160NW-HB with this department under the provisions of DCS Act & Rules and Bye-Laws of the Society;

And whereas, Sh. Rajeev Ranjan, SDM (Civil Lines), who was appointed as Administrator-cum-Returning Officer vide this office order dated 29.11.2021 resigned on 02.02.2022. And consequent upon his resignation Sh. Pramod Kumar, SDM (HQ) North, was appointed as Administrator-cum-Returning Officer vide this office order dated 25.02.2022. Sh. Pramod Kumar informed this office via his letter dated 08.03.2022 that it is not possible for him to work as Administrator-Cum-Returning Officer and requested that this responsibility may be given to some other officer.

And whereas, the Registrar Co-operative Societies has now approved that Sh. Anil Bhatnagar, SDM (Retd.) be appointed as Administrator under Section 35(5) of DCS Act, 2003 of the Society in place of Sh. Pramod Kumar, with immediate effect. A remuneration of ₹.10,000/- (Rupees Ten Thousand Only) per month and Traveling Allowance applicable as per circular dated 29.09.2016 (copy enclosed) shall be paid from the funds of the Society and to hold the election of the Managing Committee of the Society within the stipulated period of 90 days from the date of appointment as Administrator.

Sh. Rajeev Ranjan, SDM (Civil Lines), the then Administrator-Cum-Returning Officer is hereby directed to handover the charge of the record of the Society/relevant documents to Sh. Anil Bhatnagar, SDM(Retd.), Administrator immediately under intimation to this office within 07 days from the receipt of this order.
