ORDER

Whereas, the Silver Oak Cooperative Group Housing Society Ltd., Plot No.109, I.P.Extension, Delhi-110092, is registered with this Department vide Regn. No.406/GH.

And whereas, Sh. Divesh Kumar Garg, Ex-Administrator-Cum-R.O. resigned from the post of Administrator-Cum-R.O. vide letter dated 18.05.2022 due to non-cooperation of the Society and other problems.

Now, therefore, the approval of Secretary-cum-RCS is hereby conveyed to appoint Sh. Praphul Kumar Sundriyal, Administrative Officer, Food & Safety Department, GOI as Administrator-cum-Returning Officer in the aforesaid society u/s 35(5) of DCS Act, 2003 to manage the day-to-day affairs of the society and also to conduct election in the Society within a period of 90 days from the date of issue of this order. He is entitled to receive Rs.10, 000/- (Rs. ten thousands only) per month as honorarium plus conveyance charges, out of the society funds.

The other expenses of the election will be met out from the funds of the society. The election of the Managing Committee of the aforesaid society shall be conducted as per the guidelines for the elections available in Rule 53 and of Schedule-II of DCS Rules, 2007.

Further, the Ex-President/Ex-Secretary, MC members of the society are hereby directed to handover all the records/documents of the society to the Administrator-cum-Returning Officer within 07 days from the date of receipt of this order.

This issues with the prior approval of Secretary-cum-Registrar, Cooperative Societies.
