**ORDER**

Whereas a communication was received from Sh. As per Section 19 of the Right to Information Act, 2005, the Appellant may file an appeal, if any, within 90 days of the issue of this order before Second Appellate Authority i.e. Central Information Commission, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi -110067.
