ORDER

Whereas, the Navyug Adarsh CGHS Ltd., F-Block, Vikas Puri, New Delhi – 110018 is registered with this department at Regn. No. 352 under the provisions of DCS Act and Rules.

And whereas, Shri Mahendra Pratap Singh, Retd. Asstt. Director, DDA has been appointed as Administrator-cum-Returning Officer in Navyug Adarsh CGHS Ltd. vide this office order of even no. dated 28/03/2022.

And Whereas, Shri Mahendra Pratap Singh, Retd. Asstt. Director, DDA, Administrator-cum-RO vide letter dated 30/05/2022 has requested to issue instruction regarding elections of Managing Committee of society either without Audit or otherwise.

Now, therefore, the Worthy RCS, GNCT of Delhi in exercise of the power vested in him under DCS Act & Rules (1) extend the tenure of Shri Mahendra Pratap Singh as Administrator-Cum-Returning Officer for subsequent term of 90 days to manage the affairs of the society and to conduct the fresh election of the Managing Committee of Navyug Adarsh CGHS Ltd. u/s 35(5) of DCS Act, 2003 (2) Permission is also granted to the Administrator-cum-RO to initiate election without Audit and simultaneously **the Administrator-cum-R.O. is also directed to get the Audit conducted for the F.Y. 2018-19 to 2021-22 and then complete the election process within extended period only.** The Worthy RCS also accord approval for payment of honorarium of Rs.10,000/- (Rupees Ten Thousand Only) per month alongwith other expenses to the Administrator-cum-Returning Officer for this purpose out of the society funds.

The AR(Audit), O/o RCS, is also directed to appoint an Auditor to conduct the Audit of the Navyug Adarsh CGHS Ltd. for the F.Y. 2018-19 to 2021-22.
