ORDER

Whereas the applications dated 22/03/2022, 22/03/2022, 02/05/2022, 30/05/2022 & 13/06/2022 under RTI Act, 2005 were filed by Appellant - Sh. Arun Kumar Goyal, r/o 455/31, Prem Nagar, Janta Colony, Rohtak-124001 vide ID nos. 208,259,286,354 & 383 dated 05/04/2022, 26/04/2022, 06/05/2022, 08/06/2022 & 20/06/2022 respectively.

It is stated by the Appellant that despite directions issued by PIO (RCS Office) to information provider of society i.e. President/Secretary, Vaish Cooperative Commercial Bank Ltd, 881-82, Nai Sarak, Delhi, information has not been provided till date of filing this appeal. Accordingly Sh. Arun Kumar Goyal has filed appeal before First Appellate Authority.

The appeal is disposed of as under :-

The PIO/AR (Banking) is directed to collect the required information from the concerned Society and provide the same to the appellant within 15 days of receipt of this order in terms of provision of RTI Act, 2005. Also, if the applicant desires, he may be allowed to visit the office of the PIO to inspect the available records relating to his application to get the copies of required information as per provisions of RTI Act, 2005.

As per Section 19 of the Right to Information Act, 2005, the Appellant may file an appeal, if any, within 90 days of the issue of this order before Second Appellate Authority i.e. Central Information Commission, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi -110067.
