ORDER

Whereas, Shivalika Cooperative Group Housing Society Limited, Plot No. 16, Sector-9, Dwarka, Phase-I, New Delhi-110077, is registered in this Department vide Regn. No. 983/GH under the provisions of DCS Act & DCS Rules.

And whereas, the Competent Authority has appointed Sh. Harvinder Kumar, Dy Director, Ministry of Finance ,GOI as Administrator-Cum-RO in the aforesaid society u/s 35 (5) of DCS Act, 2003 to manage the day to day affairs of the said Society.

Now, therefore, I, Huckam Chand, Asstt. Registrar (H/SEC-VII) hereby convey the approval of the Registrar Co-op. Societies to appoint Sh. Harvinder Kumar, Dy Director, GOI as Administrator-Cum-R.O. in the Shivalika Cooperative Group Housing Society Limited under section 35 (5) of Delhi Co-op. Societies, Act, 2003 for the period of 90 days to manage the day to day affairs of the Shivalika Cooperative Group Housing Society Limited and conduct the election of the Managing Committee of the said Society as per the Schedule II of the DCS, Rules, 2007. The Administrator-Cum-Returning Officer shall submit the status report and factual position of the society in all respect within 30 days assuming the charge of the society.

He shall be paid of Rs. 10,000/- (Rupees ten thousand only) per month as honorarium and conveyance charges sfrom the society funds.

The Ex-Administrator of the society is hereby directed to handover all the records/ documents of the Society to the Administrator-Cum-R.O.
