ORDER

Whereas, NZPH Railway Employees CGHS Ltd., Plot No.7, Geeta Colony, Delhi-110031 is registered with this Department vide Regn. No. 507/GH.

Whereas, Sh. B.S. Rana (Retd. DANICS) vide order dated 05/10/2021 was appointed as Administrator-cum-Returning Officer of the NZPH Railway Employees CGHS Ltd. u/s 35(5) of DCS Act 2003 to manage the affairs of the society and to hold the election of the Managing Committee.

Whereas, Sh. B.S. Rana(Retd. DANICS) vide order dated 21/02/2022 has got his tenure extended with his de-novo appointment as Administrator-cum-R.O. but still after getting various opportunities, election could not be conducted in the said society.

Now, the undersigned is directed to convey the approval of the Registrar Co-operative Societies, GNCT of Delhi, in exercise of the powers vested in him under DCS Act & Rules to appoint **Sh. I.S. Gulati, Retd. Income Tax Officer** as Administrator-cum-Returning Officer in place of Sh. B.S. Rana(Retd. DANICS) in the NZPH Railway Employees CGHS Ltd. under section 35(5) of DCS Act, 2003, to manage the day-to-day affairs of the Society and to hold the election of the Managing Committee of the society as per Schedule II of DCS Act & Rules within Ninety (90) days from the date of his appointment. The Administrator-cum-R.O., on expiry of the period of 90 days will not exercise any financial powers till the term is further extended by the Competent Authority. An honorarium of Rs.10,000/- (Rs. Ten Thousand Only) per Month plus other expenses will be paid to him from the society funds.

This issues with the prior-approval of the Competent Authority.
