### ORDER

Whereas, the New Ashoka CHBS Ltd., Ashoka Bhawan, Ashoka Niketan, Delhi-110092 is registered with this department vide Registration No. 95/HB.

And whereas, the Managing Committee of the said society was formed on dated 12/12/2021 in the election held under the power of Election/Returning Officer Sh. B.M. Agarwal.

And Whereas, various complaints have been received in this office regarding illegal nexus in committing various malpractices and misappropriation of funds by the office bearers of the Managing Committee of New Ashoka CHBS Ltd. and MC is not working as per the societies Registration Act and Rules and the allegations are proved to be serious in nature.

And Whereas, the President of the Society has failed to comply with the directions of RCS office, leaded to stalemate in the functioning of the Managing Committee of the Society though sufficient opportunity has been afforded to the society but the replies received are evasive and do not controvert the allegations made.

Now, therefore, the undersigned is hereby directed to convey that the Registrar Cooperative Societies, GNCT of Delhi in exercise of the power vested in him under DCS Act & Rules superseded the Managing Committee of the New Ashoka CHBS Ltd. u/s 37 of DCS Act, 2003 and further pleased to appoint **Sh. Tapan Jha, SDM(Election)**. Shahdara, as Administrator-Cum-Returning Officer u/s 37 (1)(b) of DCS Act, 2003 to manage the affairs of the society and to conduct the fresh election of the Managing Committee of New Ashoka CHBS Ltd. within a period of One Hundred and Eighty days from the date of issue of this order. An honorarium of Rs.10,000/- (Rupees Ten Thousand Only) per month plus other expenses will be given to him for this purpose out of the society funds.

This order has been issued with the prior approval of the Competent Authority.
