Whereas, NDMC CHBS Ltd., Bal Vatika, Sukh Vihar, Delhi-110051 is registered with this Department vide Regn. No. 925/HB.

Whereas, Shri R.K. Gupta was earlier appointed as Returning Officer in the society u/s 35(1) of DCS Act, 2003 vide this office order of even no. 359-361 dated 12/07/2021 to conduct the elections in the society.

Whereas, Shri R.K. Gupta, Retd. Adhoc DANICS was appointed as Administrator-cum-RO u/s 35(5) of DCS Act, 2003 on 12/07/2021 in the society as the term of the M.C. of the society was expired on 16/09/2021. The tenure of Sh. R.K. Gupta was extended vide order dated 22/10/2021.

Whereas Shri R.K. Gupta, Administrator-cum-RO, has resigned on 24/02/2022.

(DANICS) as Administrator-cum-Returning Officer in NDMC CHBS Ltd. under Section 35(5) of DCS Act, 2003 to manage the day-to-day affairs of the society and to hold the election of the Managing Committee of the society as per the guidelines for the elections available in Rule 53 of Schedule II of DCS Rules, 2007 within Ninety(90) days from the date of his appointment. The Administrator-cum-R.O., on expiry of the period of 90 days will not exercise any financial powers till the term is further extended by the Competent Authority. An honorarium of Rs.10,000/-(Rs. Ten Thousand Only) per Month plus other expenses will be paid to him from the society funds.
