ORDER

Whereas, Ghalib Memorial CGHS Ltd. is registered vide registration No.163/GH with this department under the provisions of DCS Act/Rules & registered Bye-Laws of the society.

Whereas, A meeting was held in the Camp office of Hon'ble Minister (Social Welfare, Women and Child Development, RCS SC/ST/ST/OBC Welfare & Gurudwara Election) regarding complaint for non implementation of the order dated 17.02.2020 passed by RCS directing Special Audit of Ghalib Memorial CGHS Ltd. and for the non-compliance by its Managing Committee and also against DCHFC for charging soaring interest in violation of the DCS Rules, 1973.

Whereas, in the said meeting, it was decided that and Inspection be carried out to readdress due complaint made by the residents of the society into the embezzlement of money in the Ghalib Memorial CGHS Ltd. and Inspection Report be submitted.

Accordingly, Sh. Chanderveer Singh, Jt. Secy. (Retd. GOI) was appointed as an Inspection Officer under Section 61(1) of DCS Act, 2003 vide this office order F. 47/163/AR/Sec-3/GH/RCS/2021/1198-1203 dated 27.10.2021 to inspect the record of Ghalib Memorial CGHS Ltd. in r/o charges leveled by complainant Sh. Sajid Raza Khan by letter dated 22.09.2021 in to the embezzlement of money in the Ghalib Memorial CGHS Ltd.

The Inspection report was completed and submitted by Sh. Chanderveer on 27/05/2022. It has been noticed by this office that the Inspection Officer was not eligible to be appointed being a retired person. As an Inspection Officer is appointed in violation of proviso of Section 61 of the DCS Act, 2003. Also the period of 60 days for completion of the Inspection expired on 25.12.2021 but no report submitted within the specified period nor any interim report was submitted for extension as per mandate Rule 82(3) of DCS Rules, 2007.

Now, therefore, the competent authority has decided to recall the order dated 27.10.2021 to be null and void quo the appointment of Sh. Chanderveer Singh, a retired person in violation of DCS Act, and Rules. Hence, the Inspection Report submitted by Sh. Chanderveer Singh may be treated as null and void.

This issues with the prior approval of Competent Authority.
