ORDER

Whereas, Nanda Devi CGHS Ltd., Plot No.-19, Sector-10, Dwarka, New Delhi-110075, is registered with this Department vide Regn. No. 919/GH.

Whereas, Shri Rita Vohra, Ex-Govt. Official was earlier appointed as Returning Officer by the society itself and conducted the elections held on 08/05/2022 for the formation of the new MC of the society.

Whereas, all the Members of the Managing Committee have resigned and requested this office to take a necessary action as per DCS Act, 2003 and Rules, 2007.

Now, the undersigned is directed to convey the approval accorded by the Competent Authority i.e. Worthy Registrar Cooperative Societies, GNCT of Delhi to appoint **Shri Soran Singh, Deputy Director, Social Welfare** as Administrator-cum-Returning Officer in Nanda Devi CGHS Ltd. under Section 35(5) of DCS Act, 2003 to manage the day-to-day affairs of the society and to hold the election of the Managing Committee of the society as per the guidelines for the elections available in Rule 53 of Schedule II of DCS Rules, 2007 within Ninety(90) days from the date of his appointment. The Administrator-cum-R.O., on expiry of the period of 90 days will not exercise any financial powers till the term is further extended by the Competent Authority. An honorarium of Rs. 10 000/- (Rs. Ten Thousand Only) per Month plus other expenses will be paid to him from the society funds.
