Whereas, New Friends Cooperative House Building Society Ltd., New Friends Colony CHBS Ltd., 91, New Friends Colony, (Opp. D-896), New Delhi-110025, is registered with this Department vide Regn. No. 1265/HB.

Whereas, the last elections were held on 06/10/2019 in the society and the tenure of the Managing Committee has already expired on 05/10/2022.

Whereas, now, the Managing Committee of the said society has requested this office to take a necessary action as per DCS Act, 2003 and Rules, 2007 for the formation of new Managing Committee.

Now, the undersigned is directed to convey the approval accorded by the Competent Authority i.e. Worthy Registrar Cooperative Societies, GNCT of Delhi to appoint **Shri Suresh Chand, F.S.O., Food and Supplies Department** as Administrator-cum-Returning Officer in New Friends CHBS Ltd. under Section 35(5) of DCS Act, 2003 to manage the day-to-day affairs of the society and to hold the election of the Managing Committee of the society as per the guidelines for the elections available in Rule 53 of Schedule II of DCS Rules, 2007 within Ninety(90) days from the date of his appointment. The Administrator-cum-R.O., on expiry of the period of 90 days will not exercise any financial powers till the term is further extended by the Competent Authority. An honorarium of Rs.10,000/- (Rs. Ten Thousand Only) per Month plus other expenses will be paid to him from the society funds.
