Whereas, SBI Employees Cooperative Group Housing Society Ltd., Road No.42, Bank Vihar, Pitampura, New Delhi-110034, is registered with this Department vide Regn. No. 581/GH.

And whereas, the last election of the Society was conducted on 18.08.2019 and the tenure of Managing Committee is already completed on 17.08.2022 & R.O. appointed by the Society informed vide letter dated 07.08.2022 that no members are interested in contesting election for the M.C. of the Society.

And whereas, the Registrar Cooperative Societies, has approved to appoint Sh.Deepak Kumar,S.O., GNCTD as Administrator-Cum-Returning Officer as per the provision of section 35 (5) of DCS Act, 2003 to manage the day to day affairs of the Society and to hold the election within the stipulated period.

Now, therefore, I, Huckam Chand (Sec-VII), hereby convey the approval of the Competent Authority, i.e. RCS to appoint Sh. Deepak Kumar, S.O. as Administrator-cum-RO in the aforesaid Society u/s 35(5) of DCS Act, 2003 to manage the day to day affairs of the society and to conduct the election of the Managing Committee of the Society within a period of ninety days from the date of his appointment. He is entitled to receive Rs. 10,000/- (Rupees Ten thousand only) per month as honorarium and conveyance charges, out of the funds of the Society. The election process be conducted as prescribed in Rule, 53, Schedule-II of DCS Rules, 2007.

Further, the Ex-President/ Secretary and R.O. of the Society are hereby directed to handover all the records/ documents of the Society to the newly appointed Administrator-cum-RO.
