Whereas, the Nav Bharat Times CGHS Ltd., Nav Bharat Times Apartments, Mayur Vihar, Phase-I, Delhi-110091 is registered with this department at Regn. No.-58/GH under the provisions of DCS Act and Rules.

Whereas, the last election for the formation of Managing Committee was conducted by Sh. S.S. Verma, Returning Officer held on 10/08/2019 and tenure of MC has already expired.

Whereas, the members of the society and Sh. A.K. Kaushal, Arbitrator has requested this office to appoint an Authorized agency to arrange the elections for the formation of New Managing Committee of Nav Bharat Times CGHS Ltd.

Now, therefore, the undersigned is directed to convey the approval accorded by the Competent Authority i.e. Worthy Registrar Cooperative Societies, GNCT of Delhi to appoint **Shri R.K. Mudgal, Retd. Assistant Director**, as Administrator-cum-Returning Officer in Nav Bharat Times CGHS Ltd. under Section 35(5) of DCS Act, 2003 to manage the day-to-day affairs of the society and to hold the election of the Managing Committee of the society as per the guidelines for the elections available in Rule 53 of Schedule II of DCS Rules, 2007 within Ninety(90) days from the date of his appointment. The Administrator-cum-R.O., on expiry of the period of 90 days will not exercise any financial powers till the term is further extended by the Competent Authority. An honorarium of Rs.10,000/-(Rs. Ten Thousand Only) per Month plus other expenses will be paid to him from the society funds.
