Whereas, Shivaji Cooperative Group Housing Society Limited, Plot No. 4/1, Sector-14, Rohini, New Delhi-110085, is registered in this Department vide Regn. No. 65 /NW/GH under the provisions of DCS Act & DCS Rules.

Whereas, Sh. Manoj Kumar, Retd. IAS was appointed as Administrator-cum-R.O vide order dated 12/4/21 u/s 35(5) of DCS Act, 2003.

And whereas, the Competent Authority has appointed Sh. Tapan Jha, Adhoc DANICS, GNCT of Delhi as Administrator-Cum-RO in aforesaid society u/s 35(5) of DCS Act, 2003 to manage the day to day affairs of the said Society.

Now, therefore, I Suman Kumari, Asstt. Registrar (H/Sec-VII) hereby convey the approval of the Registrar Co-op. Societies to appoint Sh. The Administrator-cum-RO shall submit the status report and factual position of the society in all respect within 30 days assuming the charge of the society.

He shall be paid of Rs. 10,000/- (Rupees Ten Thousand only) per month as honorarium and conveyance charges with election expenses from the society funds.

The Ex-Administrator cum R.O of the society is hereby directed to handover all the records/documents of the Society to the Administrator-cum-R.O.
