ORDER

And whereas for this lapse, process to terminate his services was initiated and during the proceedings, he submitted an application dated 10.01.2022 and an undertaking dated 14.01.2022 requesting him to allow to join his duties and promised not to repeat such irresponsible conduct in future.

And whereas his request was accepted and he was allowed to join his duties with the condition that if he repeats the same in future his services shall be terminated.

And whereas he is again absent from his duties since 14.02.2022 without any permission / information.

And whereas the Memorandum dated 23.02.2022 sent to him by the H.O.O., GSSD, Kalkaji on his address available in records has been received back with the remarks of the Postal Authorities "No such person" meaning he has changed his address without informing the Department.

And whereas long absence and that too without any information, of a teacher from School adversely affects the education of the students of the School.

And whereas because of the aforementioned position, the competent authority has decided to terminate the services of the said Sh. Kirpa Shankar Tiwari.

Now therefore, the services of Sh. Kirpa Shankar Tiwari, Asstt. Teacher (Contractual) is terminated with immediate effect.
