# The scope of work of the District Facilitation cum Grievance Redressal Committee shall

- 1. Identification of bottlenecks in service delivery system of Financial Assistance Schemes.
- 3. Facilitating and co-ordination with different stakeholders such Banks, local Bodies for 2. Assistance to applicants in access to schemes.
- 4. Suggesting measures for strengthening the functioning of helpdesk created at the district
- 5. Support in information, Education & Communication (IEC) related with Govt. schemes meant for vulnerable groups.
- 6. The District Grievance Redressal Cum Facilitation Officer (DGRO)/Welfare officer concerned shall be supported by helpdesk functionaries to identify grievances & give monthly compiled status.

## The Norms/ Terms & Condition of the District Facilitation Cum Grievance Redressal Committee shall be as under:

- 1. The committee shall meet on monthly basis on first working day of every month at 10:30
- 2. Members will attend regular monthly meetings and share minutes of the meeting with
- 3. Code of conduct and behaviour of the committee members shall be ideal so that credibility and reputation of the department shall not be compromised.
- 4. No member of the committee create any hindrance in the working of Govt. official while
- 5. Members of the committee for Redressal of the grievances (if any) preferably visit the district Offices from 2PM to 4PM on any working day.
- 6. The members are expected to extend support in identification of genuine beneficiaries and removing the deficiencies in the applications. At the same time members may also extend support in identifying undeserving cases like death etc.
- 7. There shall be no financial implication for this committee. No TA/DA shall be
- 8. The nominated member shall attend the meeting in person and there shall be no further delegation.
