ORDER

Department of WCD is implementing Supplementary Nutrition Programme in Delhi under ICDS with the support of Non Profit Organizations who provide Take Home Ration (THR) and Hot Cooked Meal (HCM) to the registered beneficiaries of the Anganwadi centers in the 95 projects in Delhi. Swami Sivananda Memorial Institute of Fine Arts and Craft (SSMI) has been providing Supplementary Nutrition in 3 ICDS projects namely Jehangirpuri, Nawada and Madipur. However, the organization and its SHGs have sought to cease its operations and will not be serving Supplementary Nutrition in the form of THR and HCM in these projects after 30.09.22. In view of this, these Anganwadi centers are to be attached with the NPO serving in the nearest projects as below -
