Expenditure involved on meeting the expenditure on payment of salary and allowances/ consolidation remunerations to the staff shall be debitable under Plan Scheme GIA to Mission Vatsalya; (Central Share), Major Head "2235 02 102 14 00 36 (CCS) and GIA to State Child Protection Society (State Share) salaries " 2235 02 102 13 00 36 " for the financial year 2022-23.
