The duly filled in declaration form **shall furnish to the DDO, Accounts Section (HQ)** by **<u>01.12.2022 positively</u>**, otherwise the Income Tax, as per available information, shall be deducted from the individual's salary from the month of December 2022, January 2023 and February 2023.
