The above posts are already approved by the Government of India under Poshan Abhiyaan (centrally sponsored Scheme) and funds to the tune of 80% for salary expenditure of these posts is to be borne by GOI and 20% by state Government as per pattern of 80:20 for the period of 1<sup>st</sup> April, 2022 to 30<sup>th</sup> November, 2022. With effect from 1/12/2022 with reference to letter no. F.No. PA/275/2022-CPMU (e-101875) dated 21/11/2022 from Gol the ratio of central and state share will be 60:40.

The posts/contractual/ personnel approved vide this order will be over and above the posts already sanctioned for SPMU, DPMU, BPMU of GNCT of Delhi and the creation shall be valid subject to funds being provided by Govt. of India/Govt. of Delhi for the purpose for which posts are created.

The above extension of posts is subject to following conditions:

1. That budget/funds are released by Government of India for the Scheme POSHAN ABHIYAAN.
2. That provision of funds to meet the expenditure on Wages/Salary and allowance/honorarium of the staff is made in the relevant Budget head of the scheme.
3. Posts are required for due discharge of the duties for implementation of the project during the relevant period for which the continuation is approved.
4. The projects for which the posts are created remain operational during the relevant period.
5. The order is valid in respect of the posts which are not lying vacant for more than one year of the posts which remain vacant for more than one year and subsequently revived by the competent authority from time to time.
6. Compliance of all codal formalities under GFR, 2017 and all guidelines issued by the GOI & GNCTD from time to time and also subject to availability of funds.

Expenditure involved on meeting the expenditure on Wages/Salary & allowances in respect of above posts shall be debit-able to respective Head of Accounts of Saksham Anganwadi and POSHAN 2.0, Poshan Mission- Wages 2235 02 102 17 96 02 (CSS) & 2235 02 102 16 96 02 (State Share).
