

9. No seating arrangements is allowed in the set back area of the building.

Note - Building comprised of Basement, Ground & 3 Upper Floors only, Basement is being used as storage purpose and three upper floors are used as guest house. Fire safety certificate for guest house has already been issued by this department vide letter no F6/DI S/MS/L11/WZ/2019 620 dated 13/08/2019. Proposed restaurant is on ground floor only. Covered Area of ground floor is 226.09m² and no of occupants as per NBC (Part-IV) comes out to be 126 (226.09 / 1.8 = 126) which is covered under DFS Act 2007 & Rules 2010.

The fire protection system provide in the building were tested, checked and found functional at the time of inspection. The shortcomings issued by this department vide letter no F6/DFS MS/MN GH 2022 93 dated 01/02/2022 has been complied.

Keeping in view of the Substantial compliance of the minimum standards of fire prevention and fire safety required under the rules it is recommended to grant Fire Safety Certificate under rule 35 of the Delhi Fire Service Rules 2010 is recommended.
