- The owner/occupier shall apply for renewal of this Fire Safety Certificate to the Director in the Form 'J' [sub rule (1) of rule 37] along with a copy of this Certificate, six months prior to its expiry.
- 9. In case of usage of third floor for schooling purpose then this FSC will be null and void.
