



FIRE SAFETY CERTIFICATE

Certified that the M/s Arina Inn situated at 38, Netaji Subash Marg, Daryaganj, Delhi - 06, comprised of Ground + 04 upper floors, ground floor- (commercial use), 1st floor - (09 guest rooms + reception), 2nd floor - (10 guest rooms), 3rd floor - (10 guest rooms) & 4th floor - (04 room + lift room + terrace), total 29 guest rooms upto 3rd floor was granted FSC by this department vide letter no. F6/DFS/MS/GH/NDZ/2019/2205 dated 25.11.2019. Now, the building/ premises was re-inspected by the officer concerned of this department on dated 18.01.2023 in presence of Mr. Sarwar (Manager) and found that the building is comprised of ground + 04 upper floors and now the floor wise occupancy is ground floor- (commercial use), 1st floor - (09 guest rooms + reception), 2nd floor- (10 guest rooms), 3rd floor- (10 guest rooms) & 4th floor- not in use as per affidavit dated 14.10.2019. The building has deemed complied with the fire prevention and fire safety requirements in accordance with Rule 33 of Delhi Fire Service Rules, 2010. Accordingly, the premises is fit for occupancy of "Residential (Sub Division-A-1), 1st floor - (09 guest rooms), 2nd floor - (10 guest rooms) & 3rd floor - (10 guest rooms), total 29 guest rooms upto 3rd floor only, with effect from 24/01/2023 for a period of three years in accordance with Rule 36 unless renewed under Rule 37 or sooner cancelled under Rule 40 and subject to conditions under Rule 38 of Delhi Fire Service Rules, 2010 printed below.

3. The trained fire fighting staff should be available round the clock.
4. Any deviation w.r.t. construction etc. shall be verified by the concerned building sanctioning authority.
5. This fire safety certificate may not be treated in any case for regularization of unauthorized construction, if any.
6. The owner / occupier shall submit a declaration every year in form 'K' provided in the first schedule of Delhi Fire Service Rules 2010. The form is available on www.dfs.delhigovt.nic.in.
7. The means of escape shall be kept unobstructed / unlocked for unhindered evacuation in case of an emergency.
8. The owner/occupier shall apply for renewal of this Fire Safety Certificate to the Director in form 'J' [sub Rule (I) of Rule 37] along with a copy of this Certificate, six month prior to its expiry. Any change in the occupancy shall be intimated to this Deptt. and approval shall be obtained thereto before occupancy of the same.
9. The occupancy of 4th floor not allowed as per clause 7.31 in UBBI.-2016.
