


FIRE SAFETY CERTIFICATE

Certified that the Coral Plaza Guest House located at 2039/7, Gali No. 7, Chauna Mandi, Pahar Ganj, New Delhi is comprised of Ground + 04 Upper floors, Ground floor (02 guest rooms + Reception), 1st floor to 3rd floor (04 guest rooms at each floor) 4th floor not in use as per affidavit dated 24.12.2019, total 14 guest rooms up to third floor only, The FSC was earlier granted by this department vide letter No.F6/DFS/MS/GH/NDZ/2020/88 dated 04/03/20 for 14 guest rooms up to third floor only. Now, the premises was re-inspected by the officer concerned of this department on 25/01/23 in the presence of Manager and found that the said guest house building have deemed complied with the fire prevention and fire safety requirements in accordance with rule 33 of the Delhi Fire Service Rules, 2010 and that the premises is fit for occupancy class Residential, (Sub Division-A-1) Ground floor (02 guest rooms + Reception), 1st floor to 3rd floor (04 guest rooms at each floor) total 14 guest rooms up to third floor only, with effect from 01.01.2023 for period of three years in accordance with rule 36 unless renewed under rule 37 or sooner cancelled under Rule 40 and subject to compliance of the conditions under rule 38 of the Delhi Fire Service Rules 2010, printed below.

6. The owner / occupier shall submit a declaration every year in form 'K' provided in the first schedule of Delhi Fire Service Rules 2010. The form is available on www.dfs.delhigovt.nic.in
7. The means of escape shall be kept unobstructed / unlocked for unhindered evacuation in case of an emergency.
8. The owner/occupier shall apply for renewal of this Fire Safety Certificate to the Director in form 'J' [sub rule (I) of rule 37] along with a copy of this Certificate, six month prior to its expiry".
9. Any flammable material for interior decoration is prohibited.
