

FIRE SAFETY CERTIFICATE

Certified that the DMRC Peeragarhi Metro Station (Line-5) (Elevated) Located at Peeragarhi, Delhi-110087, comprised of Ground, 1st floor (Lower Concourse), 2nd floor (Upper Concourse) & 3rd floor (Platform Level) owned/occupied by Delhi Metro Rail Corporation Ltd. was issued Fire Safety Certificate by this department vide letter no. F.6/DFS/MS/2010/827 dated 18.03.2010. The said building/Premises was re-inspected by the officer concerned of this department on 15.02.2023 in the presence of Sh. Sanyam Jain (AM/Fire) and found that the premises have deemed complied with the fire prevention and fire safety requirements in accordance with rule 33 of the Delhi Fire Service Rules 2010, and that the building is fit for occupancy Group – D 'Assembly' (Except PD Area) with effect from $0.1.1 \times 2.2.3$. for a period of three years in accordance with rule 36 unless renewed under rule 37 or sooner cancelled under rule 40 and subject to compliance of the conditions under rule 38 of the Delhi Fire Service Rules 2010 printed below.

Following fire safety directive must be adhered to:-

- 1. All the means of escape shall be kept free of all type of obstruction all the time.
- 2. All the employees shall be acquainted with the use and maintenance of all fire equipments and method of smooth and speedy safe evacuation of occupants in case of emergency.
- 3. All the fire fighting equipments shall be maintained in perfect working condition all the time and any lapse rendering non-functional if fire safety measures, management shall be responsible.
- 4. Any deviation, with regards to construction, ventilation, occupation, electric installation etc. may be got verified from the concerned authorities.
- 5. The Fire Safety Certificate may not be treated in any case for regularizations of unauthorized construction / unauthorized use of land if any.
- 6. All comments / directions of licensing Department shall always be permitted and followed.
- 7. The owner /occupier shall submit a declaration every year in form 'K' provided in the first schedule of Delhi Fire Service Rule 2010. The form is available on <u>www.dfs.delhigovt.nic.in</u>
- The owner / occupier shall apply for renewal of this Fire Safety Certificate to the Director in 'Form J' (sub Rule (1) of Rule 37) along with copy of the certificate, six months prior to its expiry.

The fire protection systems provided in the building were randomly test checked and found functional at the time of inspection.

Note on the recommendation of FPW duly approval by Worthy Director at N/21, the inspection was carried out as per Rule 35 (6) of Delhi Fire Service Rules 2010 under Delhi Fire Service Act- 2007. The shortcomings issued vide letter No. F6/DFS/MS/2019/419 dated 21.01.2019, regarding width of staircase has been relaxed as per Rule 35 (6) and rest of the shortcomings has been complied with by the DMRC management.

Keeping in view deemed compliance of the minimum standards of fire prevention and fire safety requirements under the rules, renewal of Fire Safety Certificate issued vide letter no. F.6/MS/DFS/2010/817 dated 18.03.2010 is recommended under rules 37 of the Delhi Fire Service rules 2010 under the DFS Act 2007.
