Condition for the validity of fire safety certificate

- All the fire safety arrangements provided therein shall be maintained in good working conditions at all times.
- 2 Any loss of life or property due to non functional fire safety measures shall be at the responsibility of the management.
- 3 The trained fire fighting staff should be available round the clock.
- ⁴ Any deviation w.r.t. construction etc. shall be verified by the concerned building sanctioning authority.
- 5 The basement shall be used strictly as per the provision of building bye laws.
- This fire safety certificate may not be treated in any case for regularization of unauthorized construction, if any.
- The owner / occupier shall submit a declaration every year in form 'K' provided in the first schedule of Delhi Fire Service Rules 2010. The form is available on www.dfs.delhigovt.nic.in
- 8 The means of escape shall be kept unobstructed / unlocked for unhindered evacuation in case of an emergency.
- 9 The owner/occupier shall apply for renewal of this Fire Safety Certificate to the Director in form "I' food. "J' [sub rule (I) of rule 37] along with a copy of this Certificate, six month prior to its expiry".
