
Conditions for the validity of Fire Safety Certificate

- Any deviation w.r.t construction etc. shall be verified by the concerned building sanctioning authority.
- This fire safety certificate may not be treated in any case for regularization of unauthorized construction, if any.
- "The owner/occupier shall apply for renewal of this Fire Safety Certificate to the Director in Form 'J' [sub rule (I) of rule 37] along with a copy of this Certificate, six months prior to its expiry.
- 9. Any flammable material for interior decoration shall strictly prohibited.


