Ground floor- Reception + Bank, 1st floor - 05 guest rooms, 2nd floor- 04 guest rooms, 3rd floor - 05 guest rooms total 14 guest rooms was granted Fire Safety Certificate (FSC) by this department vide letter no. F6/DFS/MS/GH/2018/SZ/773 dated 20.04.2018. The premises was reinspected by the officer concerned of this department on 19.06.2023 in presence of Mr. Salman (Manager) and found that the building /premises has deemed complied with the fire prevention and fire safety requirements in accordance with Rule 33 of Delhi Fire Service Rules. 2010. Accordingly, the premises is fit for occupancy of Group 'A (Residential) sub division A-1, having 14 guest rooms (1st floor - 05 guest rooms, 2nd floor- 04 guest rooms, 3rd floor - 05 guest rooms) and valid upto 31.03.2026 in accordance with Rule 36 unless renewed under Rule 37 or sooner cancelled under Rule 40 and subject to conditions under Rule 38 of Delhi Fire service Rules, 2010 printed below.

The owner/occupier shall apply for renewal of this Fire Safety Certificate to the Director in form 'J' [sub Rule (I) of Rule 37] along with a copy of this Certificate, six month prior to its expiry. Any change in the occupancy shall be intimated to this Deptt. and approval shall be obtained thereto before occupancy of the same.

Note:- The building was constructed in 2006 and was converted to guest house in 2015. Provision Delhi Building Byelaws were applicable to the building wherein alternate staircase was only required if travel distance exceeded 22.5 meters. In this case requirement of 2nd staircase may be exempted, as done in case of other guest houses of this area with similar conditions.

The fire protection systems provided in the building were tested, checked at random and found functional at the time of inspections.

The shortcomings issued to the building vide letter no. F6/DFS/MS/GH/SZ/2023/78 dated 20.02.2023 has been rectified by the management.

If agreed to the note above & in view of the deemed compliance of minimum standards of fire prevention and fire safety measures as required under the Rules, the FSC issued vide letter no. F6/DFS/MS/GH/2018/SZ/773 dated 20.04.2018 is recommended to be renewed under Rule 37 of the Delhi Fire Service Rules 2010.
