3.	EEs/AEEs of respective ACs to examine the technical feasibility for water and sewer connections and availability of water from DJB. (Parallel activity with S. No. 1&2)	5	5.
4.	EEs/AEEs of ACs shall put up the case to their controlling ACEs (Maintenance) for decision on the approvals/rejections based on merits of the case and extant rules in the matter.	1	6

In the case of approval from the ACE (Maintenance) concerned, EE/AEE of AC is to communicate the decision of the ACE (Maintenance) concerned to the applicant for deposition of the total IFC on water and sewerage. In case of rejection from the ACE (Maintenance) concerned, EE/AEE of AC is to upload decision of the ACE (Maintenance) concerned on rejection of NOC in OBPS portal.	1	7
6.	Applicant is supposed to deposit the IFC within 7 days of communication of the same, failing which the application shall be rejected.	6	13
7.	To upload the decision of approval/rejection of NOC in OBPS portal by EE/AEE concerned depending on deposition/non-deposition of IFC.	1	14
