

- (iii) This CDC/Look After charge shall be subject to the decision in different cases to be given by different Courts.

- (iv) The order of names in the following list of officers recommended for holding CDC/Look After Charge is NOT in order of seniority, which is yet to attain finality and therefore, this cannot and should not be produced before any court of law as proof of seniority.
