The MACP scheme is implemented vide Govt. of India Deptt. of Pers.& Trg. O.M. No.35034/3/2008-East (D) dated 19.5.2009 and the pay and the date of increment would be fixed in accordance with clarification No.2 of Department of expenditure's O.M. No.01/01/2008-IC dated 13.9.2008.

The pay and allowances of the incumbents will be fixed under the provisions of FR-22 (1) a (1) subject to the terms and conditions contained in the DOP&T Order No.35034/2008-Estt (D) dated 19.05.2009, issued under the signature of the Dy. Secy. to the Govt. Of India, subject to implementation of penalty orders etc. while implementing the above MACP scheme by the DDO concerned. The scheme is operative w.e.f. 01.09.2008.

As per Dy. Dir.(F&A)-I letter no. DJB/ ACA (F&G)/ ACP/ 2010/ 38810 dated 29.4.2010 and further corrigendum No.DJB/ACA/(F&G)/200939737 dated 30.4.2010, the officials concerned may be allowed to exercise their option for fixation of pay after accrual of increment in the lower grade if any, under FR-22(1) a (1) within one month of the issue of the order, granting the financial up-gradation under the MACP/ACP Scheme.

At the time of fixation of the pay of the above employees, the DDO will again confirm that the officials have completed at least 10/20/30 years / 12/24 years qualifying service, as the case may be, on the above dates (vide column-6) without any break or unqualified service and he should be clear from vigilance angle.

The Financial up-gradation is merely placement in next higher grade pay and this does not amount to functional /regular promotion or seniority benefit etc. in the grade.

All the conditions/stipulations contained in DOP&T OM dated 19.05.2009 be strictly followed while implementing the MACP / ACP Scheme in respect of concerned officials.


