**ORDER**

On the recommendation of the Screening Committee constituted for grant of financial up-gradation under Modified Assured Career Progression (MACP) Scheme to the DASS Cadre of Govt. of NCT of Delhi, in accordance with the instruction contained in the O.M. No. 35034/3/2008-Esst.(D) dated-19/05/2009 & OM No.22/22/2009-CSI(CR) dated 12.04.2010 of the Govt. of India, Ministry of personnel, Public Grievances & Pensions (Department of Personnel & Training), Secretary (Services) has granted 3<sup>rd</sup> Financial Up-gradation under MACP Scheme to the following DR Grade-II DASS officer, now working as Grade-I (DASS) Officer/Section Officer, who have got Non-Functional Scale (NFS) in PB-3 Grade Pay of Rs.5400/- (Revised Level-10 under 7th CPC Pay matrix) and has completed 10 years stagnation in a single Grade Pay, in the immediate next higher Grade Pay of Rs.6600/- in the hierarchy of the pay scales (Revised Level-11 under 7th CPC Pay matrix) w.e.f. the dates mentioned vide F.No.10(8)/2018/ACP Cell/Gr-I (DASS)/Services/455-62 dated: 23/09/2022 issued by Deputy Secretary (Services), Services Department (ACP Cell), Govt. of NCT of Delhi.

However, the grant of higher pay scale is subject to undertaking that in the event of overpayment which may be deducted at a later stage and the same will be recovered from his/her pay.


