**CANCELLATION ORDER**

**Cancellation of Offer of Appointment to the post of PGT (Commerce) Female**  
**Post Code 24/20**

Whereas **Ms./Smt. Sunita Sah (DOB- 29/12/1991), (Roll No. 112002400106)** has been nominated by the DSSSB for the post of PGT (Commerce) Female against Post Code 24/20 vide letter No.F.4(286)/P&P/DSSSB/2019/691 dated 24/05/2022 vide Result Notice No. 849 dated 05/05/2022 and accordingly an Offer of Appointment was issued to her vide this Directorate Memorandum even No. 1680 dated 10/08/2022, the second opportunity given to her vide Reminder-1 Memorandum even No. 2412 dated 12/10/2022 and Final Opportunity given to her vide Memorandum even No. 2668 dated 06/12/2022.

And whereas, **Ms./Smt. Sunita Sah** did not report in person on the scheduled date and time as given in the offer of appointment issued to her vide letter of even no. 1680 dated 10/08/2022, reminder-1 of even no. 2412 dated 12/10/2022 and Final Opportunity of even no. 2668 dated 06/12/2022. She has neither accepted the offer of appointment nor intimated any reason to D.R. Cell E-II for not accepting the offer of appointment and not reporting on said scheduled date and time.

As per DoPT Office Memorandum NO. 35016/2/93-Estt. (D) dated 09/08/95 wherein para 2, the following has been mentioned:

"An Offer of Appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If, however, within the specified period, a request is received from the candidate for extension of time, it may be considered by the Ministry/Department but extension beyond three months should not be granted liberally and it may be granted only as an exception where facts and circumstances so warrant and, in any case, only up to a maximum period of six months from the date of issue of the original offer of an appointment". An offer of appointment would lapse automatically after the expiry of six months from the date of issue of the original offer of appointment.

Therefore, in view of the facts and circumstances as above and since the candidate has wilfully chosen not to respond to the memorandums dated 10/08/2022, reminder-1 dated 12/10/2022 and Final Opportunity dated 06/12/2022. The candidature in respect of **Ms./Smt. Sunita Sah (Roll No. 112002400106)** is hereby **cancelled**, and her dossier returned to the DSSSB.


