In response of deficiency memo, you have submitted documents of deficiencies mentioned at sr.1 & 2 vide letter no. 3339 Dated: 24/01/2023 in this branch and you have not submitted any documents/clarification of deficiencies mentioned at sr. 3 & 4 and you have requested for more time to submit remaining documents.

As per DoPT Office Memorandum NO. 35016/2/93-Estt. (D) dated 09/08/95 wherein para 2, the following has been mentioned:

"An Offer of Appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If, however, within the specified period, a request is received from the candidate for extension of time, it may be considered by the Ministry/Department but extension beyond three months should not be granted liberally and it may be granted only as an exception where facts and circumstances so warrant and, in any case, only up to a maximum period of six months from the date of issue of the original offer of an appointment".

Further, competent authority considered your request and directed to submit the requisite documents/clarification of remaining deficiencies to DR Cell (Establishment-II) Branch of Directorate of Education, Delhi within 15 days from the date of issue of this letter.
