## Cancellation of offer of Appointment and candidature to the post of PGT(ECONOMICS) MALE, POST Code 66/20

Whereas, **Sh. KAMAL SINGH MEENA**, **D.O.B. 04/02/1986**, **Roll No. 111606600062** has been nominated by the DSSSB to the post of PGT(ECONOMICS)-MALE against Post Code 66/20 vide Result Notice No.1419 dated 22/12/2021 in the Directorate of Education, Govt. of NCT of Delhi.

Whereas, the candidate was appointed/posted at Tuglakabad Village-SBV-1925014 vide Order No: F.NO.DE-2(63)/DRC(E-II)/PGT(ECONOMICS)/MALE/2021/1292-93 dated: 22/07/2022 (Posting ID: 20220221), with the direction to join his place of posting latest by 22/08/2022.

And Whereas, **Sh. KAMAL SINGH MEENA** has given his declaration in writing via letter dated 20<sup>th</sup> Dec 2022 with the subject "Regarding Cancellation of my Appointment Letter". where the candidate has stated that he has been promoted in some other Department. So, He is unwilling to join the post of PGT (Economics), Post Code 66/20 and requested to proceed ahead with cancellation of his candidature.

As per DOPT OM no. 35016/2/93-Estt.(D) dated 09.08.1995, the following has been mentioned:

"An offer of appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If however with the specified period a request is received from the candidate for extension of time, It may be considered by the Ministry/Department but extension beyond 3 months should not be granted liberally and it may be granted only as an exception where facts and circumstances so warrant and in any case only upto a maximum period of 6 months from the date of issue of original offer of an appointment". An offer of appointment would lapse automatically after the expiry of 6 months from the date of issue of the original offer of appointment.

Therefore it is evident that the candidate is no longer interested in joining the above mentioned post. Hence, the Director (Education) being the Competent Authority ordered to <u>cancel</u> the candidature of **Sh. KAMAL SINGH MEENA**, **D.O.B. 04/02/1986**, **Roll No. 111606600062**, **post PGT (ECONOMICS)-MALE** and return his dossier to the DSSSB.
