**ORDER**

**Cancellation of Offer of Appointment to the post of PGT (Computer Science) Male**  
**Post Code 70/20**

Whereas, **Shri RAJAT RANA**, D.O.B. 18.12.1996, Roll No. 11160400005 has been appointed vide appointment order no. F.DE-2(66)/DRC(E-II)/PGT(COMMERCE)/MALE/2021/2302 dated: 12.09.2022 to the post of PGT (Commerce) and was required to join his respective place of posting by 11.10.2022. Since, the candidate did not joined the place of posting within stipulated time, therefore, vide notice of joining reminder-I no. F.DE-2(66)/DRC(E-II)/PGT(COMMERCE)/MALE/2021/2660-2661 dated: 05.12.2022 & Notice of Joining (Final Reminder) no. F.DE-2(66)/DRC(E-II)/PGT(COMMERCE)/MALE/2021/2732 dated: 22.12.2022, he was asked to join the place of posting within stipulated time, but the candidate did not joined.

1. And Whereas, **Shri RAJAT RANA** did not report in person on the scheduled date and time as given in the said appointment order, notice of joining reminder-I & Notice of Joining (Final Reminder) issued to him. He has neither joined nor has intimated any reason to this Directorate for not joining the requisite place of posting on said scheduled date and time.
2. As per DoPT Office Memorandum NO. 35016/2/93-Estt.(D) dated 09/08/95 wherein para 2, the following has been mentioned:

"An Offer of Appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If however, within the specified period, a request is received from the candidate for extension of time, it may be considered by the Ministry/Department but extension beyond three months should not be granted liberally and it may be granted only as an exception where facts and circumstances so warrant and in any case only up to a maximum period of six months from the date of issue of the original offer of an appointment". **An offer of appointment would lapse automatically after the expiry of six months from the date of issue of the original offer of appointment.**

Therefore, In view of the facts and circumstances as above and since the candidate has willfully chosen not to join the place of posting allotted to him vide said appointment order, the candidature/ appointment in respect of **Shri RAJAT RANA, 18.12.1996, 20224436** is hereby **cancelled** and his dossier returned to the DSSSB.
