**ORDER**

**Cancellation of offer of Appointment and candidature to the post of TGT (ENGLISH) FEMALE, Post Code 51/21**

Whereas, Ms. **MEGHA KURICHH, D. O. B. 09-02-1986, Roll No. 111605100002, Category UR**, has been nominated by the DSSSB to the post of TGT (ENGLISH)-FEMALE against Post Code 51/21 vide Result Notice No. 1408 dated 20/07/2022 in the Directorate of Education, Govt. of NCT of Delhi. As per application form of Ms MEGHA KURICHH, Roll No. **111605100002** it has been noticed that the candidate has selected Category-UR and Sub-category-PH: ORTHO/ (One Arm) which shows that she has taken benefits during DSSSB exam held on 14-09-2021. A Deficiency memorandum no. 5210 dated 17/10/2022 was issued by the Department to the candidate for submission of PH (Ortho) certificate as per sub-category mentioned in the application form.

Whereas, Ms. **MEGHA KURICHH** vide her letter dated 31-10-2022 informed that she had by mistake selected PH (OH) One arm category during filling the application form and she is not physical handicap person, she selected it as she had a metal plate in her right wrist and submitted a medical certificate, issued by Dr. Apurv Mehra, Vidya Jeewan Orthopedics Super Specialty Centre and requested for consideration of her candidature by ignoring PH-category.


As per general instruction for candidates issued by DSSSB, "40 minutes extra shall be given in addition to the normal time allowed of 2 hours to all the VH/PH candidates only with permission to use the facility of scribe duly verified by the DSSSB/ Centre Superintendent".

Further, in this regard, a clarification was sought from DSSSB regarding whether Ms. Megha Kurichh was availed benefits of PH category or not during examination. As per reply received from DSSSB vide letter No. F.1 (449) /CC-II/DSSSB/2021/1844 dated 18/01/2023 clearly stating that extra time of 40 minutes has been availed by Ms. MEGHA KURICHH, Roll No. 111605100002, TGT (English) Female post code 51/21.

It is clear that Ms. MEGHA KURICHH has availed the benefits of PH category at the time of examination but she has denied being a candidate for PH category.

Accordingly, as the candidate has not submitted her requisite document in support of her PH candidature and not qualified as per the recruitment rules published in advt no. **03/21** issued by the DSSSB for the post concerned, hence, the Director (Education) being the Competent Authority ordered to **cancel** the candidature of Ms. MEGHA KURICHH, D. O. B. **09-02-1986, Roll No. 111605100002, Post TGT (ENGLISH) -FEMALE, under Post Code 51/21** and return her dossier to the DSSSB.

This issues with the prior approval of the Competent Authority.
